FOUNDATION BENEFACTOR OF THE 2019 RYDELL CAR & BIKE SHOW

The event raised over \$76,000 for the Grand Forks Foundation for Education

The 14th Annual Rydell Car and Bike Show Charity Event raised \$76,141.54 for the Grand Forks Foundation for Education on September 9, 2019.

The Rydell Annual Charity Benefit Car & Bike Show is a time for the Rydell "family" to give back to the community they are proud to be part of. Each year, the Rydell employees vote on a local charity that will be the beneficiary of the charity event. 100% of all money donated at the show goes to the chosen charity including a Rydell company match of up to \$40,000. No money is taken out to cover the expenses of the show.

MONIQUE AND JOCELYNE LAMOUREUX FOUNDATION ANNOUNCES FIRST GRANT

Jocelyne Lamoureux-Davidson and Monique Lamoureux-Morando award first grant to the Grand Forks Foundation for Education to support school meals



Jocelyne Lamoureux-Davidson and Monique Lamoureux-Morando, U.S. Women's Ice Hockey Team Members and 2018 Olympic gold medalists from North Dakota, announced the first grant of their new foundation in September 2019. The grant to the Grand Forks Foundation for Education will help support students and their families who are experiencing financial hardship and need assistance with school meals.

"The main purpose of our foundation is to help level the playing field for kids in North Dakota," explained Monique and Jocelyne Lamoureux. "We are committed to helping the Grand Forks Foundation for Education be proactive around this issue. Growing up, our mother always told us to cheer for the one behind. That lesson went beyond sports and became the core of a set of values we carry with us today," they added. "This grant represents our effort to cheer for, advocate for, and fight for the one behind."

"We are so grateful for this generous gift from the Monique and Jocelyne Lamoureux Foundation," said Emilia Hodgson, executive director of the Foundation. "This grant will enable us to provide school meal support to our students, at no cost to their families. It will make a big difference in our community."

About The Lamoureux Twins

The Lamoureux twins were instrumental in helping Team USA defeat Canada for the gold medal in the Winter Olympics in PyeongChang, South Korea – the United States' first gold in ice hockey in 20 years – and are six-time world champions with two previous silver medals at the 2014 and 2010 Olympics. They are also passionate advocates for gender equity – in pay and in overall opportunity. Starting in 2014, the Lamoureux twins were leaders in the U.S. national team's fight for fair and equal treatment by USA Hockey, including more equitable support as compared to the men's hockey team and more funding for girl's youth hockey programs. In March 2017, two days before the 2017 World Championships were scheduled to start in the United States, the women's hockey team and USA Hockey were able to reach a historic agreement.



GAUKLER FAMILY FOUNDATION ESTABLISHES SOURCES OF STRENGTH FUND

Additional gift from the Altru TEARS Program bolsters the program

In October of 2019, the Gaukler Family Foundation established the **Sources of Strength Program Fund at the Foundation**. The intent of this program is to support adult advisors in Grand Forks Public Schools who are carrying out the mission of the Sources of Strength program. In doing so, the advisors work with peer leaders in their school to increase help-seeking behaviors and promote connections between peers and caring adults.



Sources of Strength is a best practice youth suicide prevention program designed to harness the power of peer social networks to change unhealthy norms and culture, ultimately preventing suicide, bullying, and substance abuse. The Sources of Strength program is currently in each of the middle and high schools. Century Elementary School is one of five elementary schools in the United States to pilot the elementary curriculum this school year.

Then, in December of 2019, Grand Forks Public Schools received a \$10,000 donation from Altru's TEARS (Together we Educate About the Realities of Suicide) to help financially support the Sources of Strength Program.

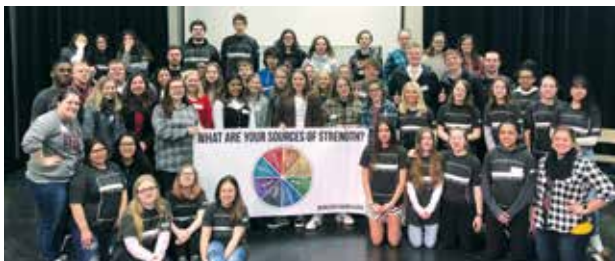
TEARS was established to support individuals and families who have lost a loved one to suicide and to provide education in hopes of preventing suicide in our community and region.

"TEARS is thankful for our partnership with Grand Forks Public Schools, specifically, the Sources of Strength program," said Moriah Opp, TEARS coordinator. "We chose to donate to Sources of Strength because we wholeheartedly believe that upstream suicide prevention programs like Sources of Strength support the mental wellness of not only this generation but future generations in our community."



Geoff Gaukler, mental health coordinator at Grand Forks Public Schools, worked with Opp to secure the donation.

#SECUREASEAT CAMPAIGN HAS A SUCCESSFUL GIVING HEARTS DAY 2020!

With Rydell Car & Bike Show matching funds we raised \$75,659

Grand Forks Public Schools, through the Grand Forks Foundation for Education, participated in **Giving Hearts Day** on February 13, 2020.

Giving Hearts Day is a 24-hour online fundraiser for charities in North Dakota and northwest Minnesota. The event is hosted by the Dakota Medical Foundation, the Impact Foundation, and the Alex Stern Foundation.

Grand Forks Public Schools raised funds to ensure a seat on the bus, at the lunch table, and in the classroom for at-risk students, those experiencing homelessness, and students in foster care. Changing lives means creating an opportunity for young people to access education that will move them from their current situation to a situation that they can dream and believe is possible.

"We know that the future of our community starts in our schools. As we continue to serve, understand, and empower our youth, we become more aware of the importance of securing a seat for every single student," said Jennifer Modeen, school social worker and homeless liaison at Grand Forks Public Schools. "With the help and partnership of the Grand Forks community, we can make a profound difference. We know the future of our students and our community depends on it."

FALL 2018, THE FOUNDATION AWARDED \$9,972 IN MINI-GRANTS

The Mini-Grants have been funded through the Foundation for Education since 1992. Awards are usually for classroom-level or grade-level projects.

All areas of curriculum and all grade levels are eligible for Mini-Grants.

Below are two of the projects funded.

\$800 to Eileen Zygarlicke and Community High School and Valley Middle School for her project, "The Power of Choice."

*Students at both Community and Valley Middle School read the graphic novel, **Monster**, adapted from the novel of the same title by Walter Dean Myers, then discussed together. "One of my kids even said that he has to start living everything he said because he realized he wasn't just speaking to the 8th graders, he was talking to himself."*



\$1,000 to Evan Pederson and West/Lake Agassiz Elementary Schools for his project, "Skate Pass Curriculum."

"While learning about skateboarding, our students have improved their balance and coordination all while learning about life long fitness in skateboarding! The students get so excited when we skateboard as it's something that many students can be successful at their own pace!"



SPRING 2019, THE FOUNDATION AWARDED \$7,879 IN MINI-GRANTS

Mini-Grant funding derives from income on permanently endowed funds. These projects provide our students with enriched opportunities, field trips to robots, and everything in between. Here are two examples.



\$1,517 to Martie Wesley and Winship Elementary School for her project, "Do the Math Intervention."

"This grant has provided necessary intervention to students in the areas of algebraic thinking and basic operations, as well as developed essential math vocabulary to ensure acceleration and growth in math concepts. It has allowed our classroom, EL and Special Education teams to work more collaboratively to meet the needs of all of our students to ensure growth and understanding of essential skills needed to succeed in higher level math."



\$2,870 to Ryan Moldenhauer and Red River High School for his project, "Game Club Expansion."



"The grant has been amazing for Game Club - students have had tons of fun playing the new consoles and games. They have enjoyed video games, card games, and board games - which they had a voice in picking, and all are collaborative and promote working within a group or team. Overall, students appreciate being supported and noticed so that they can play with new equipment and modern games."

SPRING 2019, THE FOUNDATION AWARDED \$18,342 IN IMPACT GRANTS

The Bill and Shirley Brown Endowment for Education makes the Foundation's Impact Grants possible. Income from the Brown Endowment is used to fund projects with the potential for lasting influence at the district or grade level, or at one or more schools.



\$5,792 to Missy Miedema and all 9th grade students for her project, "2019 WAR Literacy Conference - Keynote Kwame Alexander Books."

"This grant was the reason that this year's author visit was so powerful. All freshmen students read a novel by Kwame--they knew his powerful language, they felt his stories, they understood that he sees the world and its problems as they do. To read one of Kwame's books is to laugh and cry with him, and then our students got to do that again with him in person."



\$5,050 to Paul Zettler and Central and Red River High Schools for his project, "Anki Cozmo Robots and Support Equipment."

"The Anki Cozmo robots for programming has taken things to a whole new dimension, literally. While students have been excited to learn how to design programs that run on a computer, learning how to code something that they can interact with in the physical space has increased their motivation and gotten them even more excited about the possibilities."
